



Codes of Conduct

I understand that I/my child will be subject to the rules and standards of conduct of The Pennsylvania State University (“Penn State” or the “University”) when participating in a University-sponsored program. I further understand that my/my child’s violation of the rules and standards of conduct or failure to comply with the reasonable direction of Program Staff or University employee may result in my/my child’s dismissal from the Program. The Code of Conduct will include behaviors required to attend Programming/Ice Rentals during Coronavirus (COVID-19)

COVID-19 Acknowledgment

I understand that the Centers for Disease Control (CDC), Occupational Safety and Health Administration (OSHA), the Pennsylvania Department of Health, and Penn State have issued rules relating to “slowing the spread” of COVID-19. As a condition of my/my child’s participation in Pegula Ice Arena Programming/Ice Rental at Penn State, I hereby acknowledge and/or confirm the following:

- 1) I/My child will not participate in the Program/Ice Rental if, in the 14 days prior to the program/ice rental start date, I/they:
 - i. have experienced any symptoms of illness that could be associated with COVID-19, including, but not limited to, fever, cough, or shortness of breath;
 - ii. have been in close and/or direct contact with anyone who has been diagnosed with COVID-19, including, but not limited to, a family member, close friend, or relative;
 - iii. have been in close and/or direct contact with anyone who is awaiting results of a COVID-19 test, including, but not limited to, a family member, close friend, or relative;
 - iv. have been in close or direct contact with anyone who is experiencing symptoms of illness associated with COVID-19, including, but not limited to, fever, cough, or shortness of breath;
 - v. have traveled to any of the states on the Pennsylvania list for 14-day quarantine.

- 2) I/My child will follow rules and precautions to mitigate the spread of COVID-19 during program participation, including:
 - i. staying home when sick;
 - ii. wearing a face mask;
 - iii. avoiding close contact with other individuals (maintain social distancing of at least six feet, no handshaking, etc.);
 - iv. washing hands often for at least 20 seconds with warm water and soap;

- v. avoiding touching the face and eyes with one's hands;
- vi. avoiding sharing tools, phones, and other objects (items which must be shared are to be immediately cleaned after each use).

3) If, during program/ice rental participation, I/my child develop(s) symptoms of illness, or is exposed by direct or close contact to anyone who (i) has been diagnosed with COVID-19, (ii) is awaiting results of a COVID-19 test, or (iii) has symptoms associated with COVID-19, including, but not limited to, fever, cough, or shortness of breath, I agree to comply with all COVID-19 isolation and quarantine protocols issued by the CDC and/or the Pennsylvania Department of Health.

4) By completing this Acknowledgment, and voluntarily permitting me/my child to participate in Pegula Ice Arena Programming/Ice Rental, I expressly understand and acknowledge the contagious nature of COVID-19, which has been declared a worldwide pandemic by the World Health Organization, and that, even with the preventative measures put in place by Penn State, there is risk that I/my child may become exposed to and/or may contract COVID-19.

Liability Release

I/we, the undersigned, individual and/or as parent(s) and/or legal guardian(s) of the above named child, a minor, give permission to participate in programming/ice rental, sponsored/rented by Pegula Ice Arena of The Pennsylvania State University located at Pegula Ice Arena and pursuant to the Acknowledgments set forth above. In consideration of such admission, I/we do hereby agree to release, discharge, and hold harmless The Pennsylvania State University, its trustees, officers, agents, and employees of and from all actions, causes, lawsuits, liabilities, damages, claims, or demands whatsoever on account of any injury, accident, or illness involving the said minor and/or me arising out of my/my child's participation in Pegula Ice Arena Programming/Ice Rental.

Media Release

I/we grant permission to The Pennsylvania State University and its agents or employees to use photographs and/or video, taken of me/my child from this event for use in promotional and educational materials and to use such photographs/video in publications, websites, articles, brochures, books, magazines, newsletters, exhibits, broadcasts, videos, films, social media, advertisements, and training programs in any form now known or later developed. I hereby agree to release, indemnify, and hold harmless The Pennsylvania State University and its agents or employees, including any firm publishing and/or distributing the materials in whole or in part, in any medium, from and against any claims, damages, or liability arising from or related to the use of the photographs/video.
